- Pandemic Reopening and Recovery Plan reviewed and discussed with Admin Plus group
- Presentation on Reopening and Recovery Plans for individual departments were given by Tracie Labadie, Deb Coates, Patti Henning, Louis Thomas, Mark Walters, Billy Reynolds, Paige Eagan, Laura Cosby, and Denise Lindsley.

Announcements and Updates

- Replacement of Firewall/VPN will occur at the end of June.
- Due to COVID-19, there has been a temporary suspension of Fall registration. Course offerings are being revised and additional online classes are being added to the Fall semester schedule. Priority Registration will be given to those students who were already enrolled in Fall semester classes.
- Evan Pauken is looking for volunteers to make courtesy calls before and after registration suspension to the students who will be affected.
- Degree Works upgrade is scheduled for mid-June.
- ILP for Canvas integration scheduled.
- Site license visit with Zoom is scheduled. This will allow us to gain additional Zoom licenses.
- C.A.R.E.S. Act institutional funds has a one page application. Brian will send this out.
- ACD line is up and running. When students call in they will get a live person.
- Valley Food Share will start again on June 11th at AWH.
- Food service at the Food Innovation Center is starting up this week.

- KVCC Police Academy has provided all of their cadets with explicit bias and de-escalation training.
- Financial Aid has given out CARES Act money to over 550 students already. There is more money available. Please encourage students to fill out the application.
- Financial Aid will need assistance with KVAAP and FASFA in July and August.
