Announcements and Updates

- The Staff and Administrator Award nomination form is live. Nominations are due June 29, 2023.
- Kalamazoo Valley will have a presence at the Kalamazoo Farmers Market the third Saturday of each month. The college will host a community booth. Contact Rachel Bair if interested in participating.
- Kalamazoo Valley has been awarded a \$3,203,080 grant from Michigan Department Education to support a two-year project to expand our work with the Local Food Purchase Assistance program. This grant will allow the ValleyHUB to expand outreach to connect local food growers with underserved households within the Kalamazoo community. This work will be done in partnership with Kalamazoo Loaves and Fishes, Sprout Battle Creek, Milestone Senior Services and Kalamazoo Valley's Food Share. This grant will also allow ValleyHUB to expand food delivery in healthcare and education settings and will be accomplished in partnership with Bronson Healthcare, Integrated Services of Kalamazoo and Kalamazoo Valley's Community Culinary and Nutrition program.
- The HLC has approved the Groves Campus as an additional location. This approval will allow the college to offer more for-credit courses at that location.
- Vibe Fest is scheduled for September 6, 7 & 12, 2023. More info to come.
- Kalamazoo Valley will be participating in the Beyond the Backpack event to be held on September 9, 2023 at Bronson Park.
- Kalamazoo Valley Museum's Mental Health Fair will be on Saturday May 20, 2023 from 1:00 3:00. The Mental Health Matters exhibit will run until mid-June. A school group from Wisconsin is scheduled to visit the museum to see the exhibit.
