## **State Planning Process**

Dannie shared information from his conversation with the state's Project Director

- Equipment
  - o Equipment specifically pertaining to the project can be included within the project budget
  - $\circ$   $\,$  Can be mobile; does not have to be affixed to a surface
  - $\circ$  No restrictions on size
  - Both Dr. Washington and Brian stated to plan on the full project amount (\$39M) being used for construction costs
- Timeline
  - Final construction plans are due to the state by Sep. 30, 2026
    - Internal plans are projected to be submitted prior to that date
  - o After submission, there will be an on-site visit to verify plan components
  - The state will then review and hopefully approve moving forward with the project
  - After approval of project plans, project budget must be submitted to the state for approval
- Matching Funds
  - o KVCC Funds and/or Funds raised via the campaign (including pledges) will be expended first
    - Three years was suggested as an appropriate length of time for payment of pledges
  - Pending appropriate documentation, the State will disburse dollars after KVCC funds have been expended
- Budget/Expense
  - o If the project comes in under budget, the state will decrease support proportionately
  - All change orders are to be submitted to the state
  - Expenses can be submitted to the state up 12 months after "significant" completion of the project; expenses incurred after 12 months will be KVCC's responsibility
- Bid Process
  - The state must review the RFP details and rubric for selecting contractors prior to sending the RFP for bids
  - o KVCC is not required to select the lowest bid
  - o Suggested parameters for reviewing RFPs: 20% for design elements/80% for technical elements
  - Previous experience with a capital outlay project is helpful

## **Update: Initial Design/Renderings**

- TowerPinkster is compiling renderings, focusing on the exterior portions the project
- ALL angles of the construction/renovation project will be addressed, insuring a "tie in" to the entire wing
- Renderings will be available in the next few weeks

## Fundraising Update

- Alisha led a discussion relative to "making an ask"
  - Purpose is to help the donor achieve his/her philanthropy goals
  - o Discover issues etc., that resonate with the donor
- Additional discussion highlights include:
  - o A representative from the Foundation will accompany individuals on any visit
  - o It is important for the "asker" to have contributed to the campaign
  - o Awareness of the donor's affiliations (political)/connections (business and industry) is critical
    - "state need" v. "governor's" program
  - Make detailed notes as soon as possible after the visit
- Helpful Information to have in anticipation of donor questions
  - o Annette suggested reviewing a recent Grant from Lowes
  - How does KVCC support students?
  - Current partnerships
    - "KRESA partnership is good"
  - Current apprenticeships
  - o Current workforce need for graduates from technical trades programs
    - Filling current and future vacant positions
  - Stackable degrees/certifications
  - o Numerous educational opportunities in areas other than technical trades
  - Refer to regional "impact"
  - Project Case for Support
    - Project mission statement
    - Responsive to changing needs/pivoting
  - Tailor presentation to the donor

## Other

- In-kind Donation Parameters
  - $\circ$   $\;$  If the item/value is large enough, would need to get independent third-party appraisal
  - o Per Dr. Washington
    - Paige and Mark to develop recommendations/process for in-kind gifts focusing on
      - Item's value to the college
      - Costs associated with
        - o acquiring the item
        - needed maintenance, etc.

- Timeline for Temporarily Relocating Current Programs in Anticipation of Construction
  - $\circ~$  Per Dr. Washington, within the next 3-4 months
