- 1. Welcome
 - a. New member
 - i. Diane Fort, Program Coordinator, KRESA. State approved programs should have CTE presence on advisory boards.
- 2. Approve FALL 2019 Minutes
 - a. October 14, 2019
 - i. No edits to the minutes needed.
 - ii. Motion to approve, Marie Koss-Ryan; seconded by Dr. Coverly.
 - b. 2 members up for renewal; Dr. Coverly and Melissa Hudson
- 3. Admissions Information
 - a. Amy Murray worked with KVCC, Evan Pauken, Director of Student Retention to get the application process online.
 - i. 64 applicants
 - ii. 58 met the minimal requirements
 - iii. 26 were offered seats
 - iv. 24 accepted seats
 - v. 21 students are enrolled for fall of 2020
 - vi. Lowest GPA of accepted student is 3.4
 - b. The Program Coordinator, Amy Murray, talked through the process that she created using spreadsheets to capture student's individual points used to determine acceptance into the program.
 - c. KVCC is looking at using a holistic approach that will include using experience toward acceptance into the program. May include an essay to get a better look at our student that is applying. The goal is to have our student base better emulate our community cross-section. The Nursing program is going to pilot it in the spring.
- 4. Clinic Information
 - a. Accreditation update
 - i. Fall 2019

- 1. 525 patients were seen; up 72%;
- 2. Production: \$11,591.00 (up \$142.00)
- 3. Collection; \$11,031.00 (rate of 95%)
- 4. Veterans: 63 (up 30%)
- ii. Winter 2019
 - 1. Ask Kim for Powerpoint.
- iii. Updated protocols related to aerosol production in order to bring students and faculty back safely.
 - 1. Met with administrators to purchase 14 additional HVE (\$4,200) and 14 Extraoral Suctions with HEPA filters (\$16,000)
 - 2. Aerosol production began 9/16/2020
 - 3. KVCC replaced air filtration system to hospital grade
 - 4. Purchased Fogging machine, thermometors, Purvac HVE adaptors, Re-Leaf HVE adaptors and face shields (for DHY employees and 2nd year students) out of the DHY budget.
 - 5. To offset these costs, Clinical prices were increased

5. Outcome Assessments

- a. NBDHE results
 - i. 2019 graduates exceeded the standard deviation in all areas except one.
 - ii. 0% failure
- b. CDCA results used simulation mannequins
 - i. All 19 students have taken the NBDH exam and passed
 - ii. 15/15 students passed the CDCA exam on their first attempt.
 - iii. 13 have full-time jobs and 4 have part-time jobs
 - iv. 19 have state boards

6. CAPITAL

- a. 2020/2021 capital requests
 - i. Requested: x-ray machine, digital sensors, technology upgrade (\$46,000), air polisher, cavitrons, motors-cup polish, autoclave accessories and straddle stools nothing was approved due to Covid
- b. Perkins
 - i. Provided for 2 x-ray machines & accessories (aprons & sensor holders and and upgrade to 4th room with sensors (size 1 and 2)

7. DA/EFE Program with KRESA

- a. 8 students
- b. Spring of 2020 students were allowed an incomplete and worked with the Groves to complete certification.
- c. Fall of 2021 will move from 4 credits to 6 credits. Removed the WPE requirement and changed from DHY 105 to DHY 106, 113 and 278.

- a. Created a video (Dr. Mark Allen assisted) for students considering the Dental Hygiene program to be used by High School Counselors.

 - ii. Diane Fort asked to have the link shared for the KRESA website; Ana Abendshien would like to use it for KVCC undecided students.
