 - iv. 5.4 Job Placement rates, Former plan to call, no/few responses, Google survey sent Dec 23 (7), April 24 (15), responses. 100% in Nursing, Other methods?

- d. RN Completion: 10 applicants for summer 25, starting May 12
 - e. AND: fall applicants 70, typical for fall, 63 qualified, 40 accepted
Application opens 4/1 to 4/15, usually sees just over 100 applications, 3rd semester med/surg did an interdisciplinary simulation with RCP.
PN: 9 students, summer 24, 100% 1st pass rate, chart, curriculum
