Sim Center update

NBRC Update-

All 17 graduates that have taken the exam to date passed the new exam the first time. The clinical SIM exam has better results when taken close to graduation. Al's goal is to have graduates registered within six months. The Therapist Multiple Choice (TMC) may be less challenging than the written registry.

NBRC results

Weak areas on the exam were 3F (Utilize Evidence-Based Medicine Principles) with 96% and 3H (Assist a Physician/Provider in Performing Procedures) with 99%. Al said he would provide examples of NBRC physician assisted procedure questions Clinical simulation-The new exam which started January 2016 has 40 clinical-sim problems. We need to work on equipment (2A) and ensure infection control (2B)

CoARC update:

Graduates had nothing negative to say and very few were neutral. Graduates are happy with ys and think we are doing a good job. The employer survey was good overall

Clinical Update.

KVCC is still trying to develop a clinical affiliation with St. Mary's in Grand Rapids. The contract says that if there is a concern with a student we have to respond in eight hours. We have a contract with Lakeland that will start winter 2016 semester if we hear from the by the December 15th.
