**3. Call to approve minutes -**

- a. Minutes from the March 2, 2023 meeting were reviewed and approved as distributed.

**4. Program updates**

- a. Budget
  - i. Purchased a lot of tools & equipment via capital mostly for Engines class.
    - 1. Approximately \$12,000 left for the year.
    - 2. Budgeting \$3,000 for open house in spring.
- b. New Equipment
  - i. Updated OTC, 4 snap on tools, hunter ADAS, alignment machine, twin post hoist (symmetric instead of a symmetric hoist), drive on hoist, VMW EV vehicle, EVAP and starter trainers, and Autel scan tools.

**5. Comprehensive Needs Discussion Outcomes:**

- a. Employers expressed satisfaction with Kalamazoo Valley Graduates.
- b. Approximately 50% of students finish the program.
  - i. 10% follow through with AAS.
  - ii. AAS preferable to Employers.
- c. Offered class for existing technicians in preparation for brakes test.
  - i. 74% pass rate on first try, second time 100%.
- d. Discussion around barriers with Flat Rate.
- e. Skill gaps
  - i. Diagnosing electrical
  - ii. Math
  - iii. Skills for building customer base
  - iv. Suggestion to add more bugs to vehicles

**6. Updates from around the college**

- a. EV grant
  - i. Affiliated with NEVTEX run by Ferris State.
  - ii. Community colleges are getting approximately \$100,000 over the course of 3 years for tools & equipment.
- b. State battery and solar funding

- i. Receiving \$530,000 for battery and solar equipment.
    - 1. \$100,000 going to facilities, \$200,000 going to Auto program for battery, and \$200,000 going to ELT for solar program.
- c. State funding for facility
  - i. Governor signed a bill for \$19.5 million to help build a new automotive facility.
    - 1. This is half of what is needed to build the new auto wing.
- d. Donation Needs
  - i. Airbags, Subaru engines, engines with cores, junk parts and access to dealership trainings.
