Resolutions for Emeritus Status

Amendment of President Contract

It was **MOVED** by Trustee Miller and **SECONDED** by Trustee Stinson that the Employment Agreement with President Luther Marshall Washington dated July 1, 2018 be amended as follows:

Section 2.7 of Schedule "A" updated to read:

2.7 <u>Moving Allowance</u> KVCC will reimburse the President up to \$2500 for expenses incurred in moving/relocating his family/household to the Kalamazoo Area. In addition, KVCC will provide the President an allowance of \$16,000 for the relocation (packing, storage and transporting) of the President's household items/vehicles to a residence in the Kalamazoo area.

Recommendation for Naming of Facility

It was **MOVED** by Trustee Gustas, **SECONDED** by Trustee Miller, and **CARRIED** that upon the recommendation of the Board of Trustees and the President, the Kalamazoo Valley Community College Culinary and Allied Health Building located at 418 E.
