In-District	\$127.00 per contact hour
Out-of-District	\$219.00 per contact hour
Out-of-State	\$292.00 per contact hour
International	\$331.00 per contact hour

And the following non-refundable student fee shall be charged:

- Student fee of \$167.00 per semester (applicable to all students registering for courses); and
- Repeat Course Usage fee be removed.

## RESOLUTION TO PROVIDE FOR PUBLIC HEARING ON THE 2024-2025 BUDGET

#### RESOLUTION

WHEREAS, Public Act 43 of the 1963 Public Acts, as amended, requires the College to hold a public hearing on its proposed 2024-2025 budget prior to its final adoption;

WHEREAS, Section 16 of Public Act 2 of 1968, as amended, requires the taxing unit to set forth the total number of mills of ad valorem property taxes to be levied and the purposes for which that millage is levied;

NOW, THEREFORE, BE IT RESOLVED THAT:

- 1. The Board of Trustees has examined the financial circumstances of the college district for the 2024-2025 fiscal year, including estimated expenditures, estimated revenues, and the state equalized valuation of property located within the district, and determined that the levy of the total authorized millage rate will be necessary for the sound management and operation of the community college district; and
- 2. A public hearing of the proposed 2024-2025 budget be held on May 14, 2024, at 7:30 a.m., in Paul D. Jackson Board Room, at Kalamazoo Valley Community College, Texas Township Campus, 6767 West O Avenue, Kalamazoo, Michigan; and
- 3. The secretary be authorized and directed to cause a notice of such hearing to be published in the manner and time required by law in a newspaper of general circulation within the district. The notice shall be substantially in the following form:

#### NOTICE OF PUBLIC HEARING ON PROPOSED 2024-2025 BUDGET

PLEASE TAKE NOTICE that on May 14, 2024, at 7:30 a.m., in the Paul D. Jackson Board Room at Kalamazoo Valley Community College, Texas Township Campus, 6767 West O Avenue, Kalamazoo, Michigan, the Board of Trustees will hold a public hearing on the College's proposed 2024-2025 budget.

The Board may not adopt its proposed 2024-2025 budget until after the public hearing. A copy of the proposed 2024-2025 budget, including the proposed property tax millage rate, is available for public inspection during normal business hours at the Office of the President of Kalamazoo Valley Community College, 6767 West O Avenue, Kalamazoo, Michigan.

The property tax millage rate proposed to be levied to support the proposed budget will be a subject of this hearing.
