### **Approved Request**

Implement a process to cover parking for BHLC programming professional guests that are providing services and/or support at KVCC downtown campus locations.

# **Procedure**

- 1. KVCC BHLC Administration will pre-purchase \$50 stickers/passes and store them in a central location (initially AWH 212).
- Authorization to provide a pass to a guest will be done by a KVCC BHLC Budget Administrator and tracked through a log book. Approval is based on the following criteria being met:
  - a. Participation in a meeting between KVCC BHLC staff and community partners or advisory board members
  - b. Business/industry/community guests visiting with individual students or program classes including (but not limited to) personnel from:
    - i. Bronson, KCMH and Kalsec employees
    - ii. MSUe, MDARD, MFFS and state agency employees
    - iii. Local school teachers, chefs, brewers and food producers
    - iv. Public health department personnel

3. Reimbursement to be made through the appropriate budget authority and process – initially MEDC funding and, eventually, BHLC operations.

#### Grants

- Gateways to Completion KVCC has been invited to submit a full proposal through the Kresge Foundation.
- o KVCC was approved as a Title III Eligible Institution for the 2015 2016 fiscal year. This federal designation recognizes that KVCC has both low educational and general expenditures, and a significant portion of enrolled students receiving need based financial aid. The Title III designation allows the College to apply for Title III grants, and provides the College a waiver of the non-Federal share matching requirements for certain federal work study programs.
