- Replacement for IT equipment, changing operation systems, upgrades to database should be in production later in July
- Winter Graduation: 654 degrees awarded to 530 students
- Bronson Athletic Club is hosting a KalTour biking event on Sunday June 26 that will be a fundraiser for the cycling crash victims. Due to the recent event, they expect huge participation and have met with us to plan for additional parking and support.
- After listening to a webinar with the Treasury Department, we have been assured that community colleges will be 100% reimbursed for Personal Property Tax lost in FY17. As other components of the legislation take effect in 2018, reimbursement will be prorated by unit. If excess funds are available in the Local Community Stabilization Authority they will be allocated in their entirety first to Tier I institutions and then to Tier III institutions. If funds are not sufficient to reimburse institutions at 100%, Tier I institutions will be reimbursed at 100% and Tier III (Community Colleges) reimbursements will be prorated based on the funds remaining.

State Aid passed by the Conference Committee will provide KVCC \$151,067 **less** than originally projected in our FY17 budget.

KVCC has been notified that we will be audited on our 2015 MPSERS wages for all employees, independent contractors and employees under 19 years of age. Information regarding MPSERS wages is due to ORS by the end of the month.
