Michigan Sixty by 30 Adult Student Success Grant (\$200,000 over two years) and Immigrant Student Success Grant (\$150,000 on year)

The office of Sixty by 30, in partnership with the Michigan College Access Network and Global Detroit, is offering a joint application process to invest in community college's commitment to pursuing innovative ways to increase student success specifically for adult learners and international, immigrant, refugee or first-generation students. The goal for both of these grants is to equip 60% of Michigan's workforce with a post-secondary degree or credential by the year 2030. The application for both grants is due July 31, 2023.
