- 1. Call to Order The meeting was called to order at 1:04 p.m.
- 2. Meeting Minutes of April 19, 2019 The meeting minutes of April 19, 2019 were approved as presented.

- 5. Business
  - 5.1 Course Inactivations (Effective 202110)
    - 5.1.1 ART 204 Color Pencil Media (3-1-4 Lecture/Standard Lab) Background and justification information provided by Beth Purdy Over the course of the last 6 years, enrollment has dropped significantly in this course. Changing the time of the course offering, semester, and day of the week has not made an impact. Then enrollment remains low. With this inactivation a new color drawing course will be created.
    - 5.1.2 ART 208 Pastel Drawing (3-1-4 Lecture/Standard Lab) Background and justification information provided by Beth Purdy Over the course of the last 6 years, enrollment has dropped significantly in this course. Changing the time of the course offering, semester, and day of the week has not made an impact. Then enrollment remains low. With this inactivation a new color drawing course will be created.

Items 5.11 and 5.12 – These course inactivations have been endorsed by the ART faculty and advisory committee. After discussion it was MOVED, SECONDED, and CARRIED to endorse the recommendations as presented.

#### 5.2 Course Revisions

- 5.2.1 FRL 103 Elementary German I (4-4-0 Lecture /Discussion) Add blended (hybrid) (Effective 202110) Background and justification information provided by Kevin Fuchs and Billy Reynolds FRL Spanish and French course formats have been adjusted universally to a 70/30 blended format that includes 1 hour 20 minutes of face-to-face instruction, 2x/week plus additional online work. This change is being proposed for German courses as well to ensure consistency as well as to establish a class duration that is most conducive for learners of a second language, blended to provide an optimal time for face-to-face learning as well as structured individual practice outside of class.
- 5.2.2 FRL 104 Elementary German II (4-4-0 Lecture/Discussion) Add blended (hybrid) (Effective 202110) FRL Spanish and French course formats have been adjusted universally to a 70/30 blended format that includes 1 hour 20 minutes of face-to-face instruction, 2x/week plus additional online work. This change is being proposed for German courses as well to ensure consistency as well as to establish a class duration that is most conducive for learners of a second language, blended to provide an optimal time for face-to-face learning as well as structured individual practice outside of class. - 5.2.3 HRY 240 African American Experience (3-3-0 Lecture/Discussion) (Effective 202030) Background and justification information provided by Kevin Dockerty and Billy Reynolds

In an effort to better address student needs, and provide a more diverse set of course strategy options, the department proposes adding web and hybrid strategies for HRY 240. With web/hybrid available it would give the department additional flexibility to address student demands. There is no impact on existing programs, college resources, faculty load, transferability, etc.

Items 5.2.1 - 5.2.3 - These course revisions have been endorsed by the FRL and HRY faculty. After discussion it was MOVED, SECONDED, and CARRIED to endorse the recommendations as presented.

#### 5.3 New Courses (Effective 202110)

- 5.3.1 ART 209 Color Drawing Media (3-1-4 Lecture/Standard Lab) Background and justification information provided by Beth Purdy With the increased low enrollment in both ART 204 Colored Pencils and ART 208 Pastel Drawing, there is a need to create a new non-medium specific color drawing course. ART 204 and ART 208 will be inactivated and replaced with ART 209 Color Drawing Media. The new course will include many of the same learning objective as ART 204 and ART 208 with a greater focus on the understanding of color theory, techniques, and the limitations of each medium. The result should be a combined enrollment number instead of the two separate color drawing courses competing against each other.
- 5.3.2 FRL 208 Spanish Language Through Film (3-3-0 Lecture/Discussion) Background and justification information provided by Kevin Fuchs and Billy Reynolds Student/community needs: Offering another more advanced course beyond FRL 206 and FRL 255 is crucial in achieving the goal of establishing a program of study in Spanish at KVCC. This course has been deemed transferrable by our partner institutions and thus can also be useful to those wishing to continue Spanish studies at a 4 year institution towards a major, minor, or degree in education.

Items 5.3.1 - 5.3.2 - These new courses have been endorsed by the ART and FRL faculty. After discussion it was MOVED, SECONDED, and CARRIED to endorse the recommendations as presented.

- 5.5 Program Revisions (Effective 202110)
  - 5.5.1 IL CERT Illustration Certificate
    - Background and justification information provided by Beth Purdy Due to low enrollment in ART 204 and another optional color drawing course for Illustration, ART 208, there is a need to combine the two courses and create a non-specific color drawing media course. ART 204 and ART 208 will be inactivated and replaced with ART 209. There are no other changes to the certificate program.
  - 5.5.2 IL AAS Illustration AAS

Background and justification information provided by Beth Purdy Due to low enrollment in ART 204 and another optional color drawing course for Illustration, ART 208, there is a need to combine the two courses and create a non-specific color drawing media course. ART 204 and ART 208 will be inactivated and replaced with ART 209. There are no other changes to the program.
