- 3.3.1 ART 102: Foundations of 3D Design, 3-1-4 (Lecture/Discussion Standard Lab) (Online) (Blended) Effective 202210 B. Purdy discussed the recommendation of adding ART 102: Foundations of 3D Design to the program offerings stating the course was created in order to participate in MI Transfer Pathways. This new course has been endorsed by the ART and New Media faculty and advisory committee. After discussion to mas MOVED, SECONDED, and CARRIED with one abstention (D. Coates) to approve the addition of ART 102: Foundations of 3D Design to the program offerings.
- 3.3.2 ELT 104: Instrumentation I, 3-3-0 (Lecture/Discussion) (Online) Effective 202130

- D. Coates MOVED and it was SECONDED to table this item to the October 9, 2020 Course and Curriculum meeting requesting a more robust syllabus to include additional student learning outcomes. Motion carried by majority. Nay T. Sypris. Abstention C. Pruis.

 - 3.5.1 Electrical Construction ELCN; remove EDMT 102 (2-credits): Credit Total decreased from 34 to 32 overall
 - 3.5.2 Electrical Technology ELCT; add ELT 104 as "or" option for ELT 103; add WPE 112 to replace the WPE and 2-credits; combine Political and Social Science in one 3-credit requirement; remove EDMT 102 (2-credits) and move this to program elective options; program electives add CNST 101, 103, 108, ELT 103, 104, 228, HVAC 118 and remove EDMT 101, 103, and 125 from options; change program electives required credits from 6 to 9-credits so overall required credits remain 62 **Tabled until ELT 104, Instrumentation has been approved.**
