  - 3.2.2 ENG 099, Reading/Write:Writing/Read, 3-3-0 (Composition): change strategy from 4-4-0 (Composition); ALSO: lower Reading cutscore prerequisite from SAT = 19, etc. to minimum benchmarks, add corequisite with ENG 110
  - 3.2.3 MATH 070, Adaptive Mathematics, 2-2-0 (Lecture/Discussion): change strategy from 4-3-1 (Lecture/Discussion Standard Lab); ALSO: raise Math cutscore prerequisite from minimum benchmarks to ALEKS = 9, etc., adjust Reading minimum benchmark programming

  - 3.3.2 EDU 100, Career Decision Making, 1-1-0 (Lecture/Discussion): equivalent course to TRS 100
  - 3.3.3 EDU 104, College & Career/FYE, 3-3-0 (Lecture/Discussion): equivalent course to TRS 104 but change to title; removed from Reading minimum benchmark logic
  - 3.3.4 EDU 105, College Success Strategies, 3-3-0 (Lecture/Discussion): equivalent course to TRS 105; removed from Reading minimum benchmark logic

**Items 3.3.6, 3.3.7, 3.3.8** – C. Almeda discussed the recommendation of adding the above listed courses to the program offerings noting each course offers experiences that transfer directly to Western Michigan Universities four-year program. The ENG faculty endorse the new programs. After discussion it was MOVED, SECONDED, and CARRIED to endorse the recommendations as presented.

- 3.3.10 MATH 087, Foundations: Algebra I, 4-4-0 (Lecture/Discussion): compressed corequisite with MATH 088
- 3.3.11 MATH 088, Foundations: Algebra II, 4-4-0 (Lecture/Discussion): compressed corequisite with MATH 087
- 3.3.12 MATH 097, Foundations: Technical Math, 3-3-0 (Lecture/Discussion): concurrent corequisite with MATH 106
- 3.3.13 MATH 098, Foundations: Finite & Stats, 3-3-0 (Lecture/Discussion): concurrent corequisite with MATH 120

C. Almeda and N. McClure discussed the recommended course inactivations, changes, and new courses to the items listed above reporting these changes are part of a redesign to satisfy Michigan Reconnect requirements. The ENG and MATH faculty endorse the recommendations. After discussion it was MOVED, SECONDED, and CARRIED with one objection (Rick Kraas - Items 3.2.3, 3.2.4, 3.2.5, 3.3.9 – 3.3.14) to endorse the recommendations as presented.

- 3.5 Program Changes (Effective 202220 unless otherwise noted)
  - 3.5.1 Business Administration AAS: TRS 104 is being inactivated and will be replaced by EDU 104; MATH 116 is being inactivated and therefore removed from 16 credit program electives options
  - 3.5.2 General Marketing AAS: MATH 116 is being inactivated and therefore removed from 14 credit program electives options
  - 3.5.3 Health Sciences General Studies AAS: MATH 116 is being inactivated and therefore removed from MATH 115 or MATH 120 "or" options
  - 3.5.4 Law Enforcement/Criminal Justice AAS: TRS 104 is being inactivated and will be replaced by EDU 104; ALSO: MATH 116 is being inactivated and therefore removed from 4 credit gen ed math/science requirement

**Items 3.5.1 – 3.5.4** – Program changes reflect the aforementioned course inactivations, changes and new courses brought forward for consideration. The ENG and MATH faculty endorse the program changes outlined above. After discussion it was MOVED, SECONDED, and CARRIED to endorse the recommendations as presented.

3.5.5 DSS: Desk Side Support COA: add CIS 105 as "or" option to BUS 103 or 106/108/109

3.5.6 PCST.COA: PC Support Technician COA: add CIS 105 as "or" option for BUS 103 or 106/108/109

**Items 3.5.5 – 3.5.6** - T. Labadie reported on discussions with the CIS advisory committee regarding the recommendation of adding CIS 105 as an "or" option to BUS 103 or 106/108/109 noting the advisory committee brought forward a recommendation to add CIS 105 as a requirement increasing the overall credits to 21 instead of 18. The CIS faculty and advisory committee endorse this program change. After discussion it was MOVED, SECONDED, and CARRIED to endorse the recommendation as presented.
