Institutional Research

- Winter Enrollment
 - Minimal changes
 - End result will likely be within .5% of current number
 - Noted that 2022 v. 2021 in-district FTIACS are slightly down where same group out-of-district made substantial gains
 - Discussion re: traditional students looking for in-person/hybrid where Reconnect are wanting all virtual options
 - Need to identify nuances by academic plans
- Fall modalities
 - Available closer to start (2-3 weeks prior to registration); many adjustments in process.
- Summer enrollment not yet available
 - Per Evan, options to improve guest enrollment in Summer are on the radar screen
 - Per Megan, this year's campaign for guest students to be more robust
 - Angela requested to be included in planning
 - Suggestion to reach out to athletes
 - Per Sarah, applications are trending similarly to previous years
 - Other target groups include
 - Fall Reconnect who did not enroll for Winter
 - Will lost funding if they do not have a plan or enroll for Summer
- Three Year - Graduation Rate
 - Continuing upward trend, nearly 10% over the last decade
 - Metric is first time/full time student cohorts completing in <=3 years
- Retention: stable over 5 year period

EARLY REGISTRATION TUITION DEADLINE UPDATE:

A small group* of us met on March 7, 2022 to discuss the early registration tuition deadline and the need for possible changes. The reason for the discussion is due to processing constraints identified in the Financial Services and Financial Aid offices from the shortened registration pause for batch cancellation due to non-payment and the fact that this process falls on the same day as the financial aid refund process.

The group discussed a number of alternatives and ultimately determined that it is more beneficial to overall registration numbers to spend additional time ensuring the batch cancel process is completed accurately and the appropriate students were dropped (and more importantly not dropped) than it was to rush to re-open registration. Having additional time during the batch cancel process to review students in the Financial Aid department prior to the drop should result in fewer tuition delay holds and subsequent drops for non-payment/additional actions needed by the student.

We will be extending the registration “pause” by one additional day as follows [changes to go into effect starting with Fall 2022 registration]:

- Summer/Winter tuition deadline will remain on Tuesday at 7 p.m. and registration will close at that time and will re-open on FRIDAY at 7 a.m. (instead of Thursday)
- Fall tuition deadline will move to MONDAY at 7 p.m. and registration will close at that time and will re-open on THURSDAY at 7 a.m. (due to the college being closed on Fridays in the summer)
 - The Financial Aid and Financial Services offices will hold additional late hours until 7 p.m. on this additional Monday tuition deadline to accept payments and financial aid documents. Other offices that typically have late hours on Tuesdays should evaluate the potential need based on typical department traffic and staffing availability/resources.

BATCH CANCEL REVIEW PROCESS:

Once the tuition deadline has passed. Financial Aid completes their review of all documentation that has been received through the deadline and applies/awards all aid that can be processed at that time. Tuition delays are added to any students that are in process/have issues where Financial Aid does not want the student to be dropped as part of batch cancel to give additional time to review the student account.

Once Financial Aid has completed their process. Financial Services requests an initial round of batch cancel reports. These reports show the list of students scheduled to be dropped for non-payment. These reports are then reviewed by staff in our office for students that should be excluded from the drop. Typical situations would include students that have partial financial aid, but have a balance or have Kalamazoo Promise less than 100%. These students would typically get a short-term (10 day hold) to prevent them from being dropped during the batch cancel and then the students will receive an email notifying them of their balance due. Other situations where we may choose to “not” drop a student could be where a student has paid a portion of their balance (typically more than 50%), but not all of the balance, or only has a small balance remaining. These students would also get a short-term hold and would be emailed regarding their balance.
